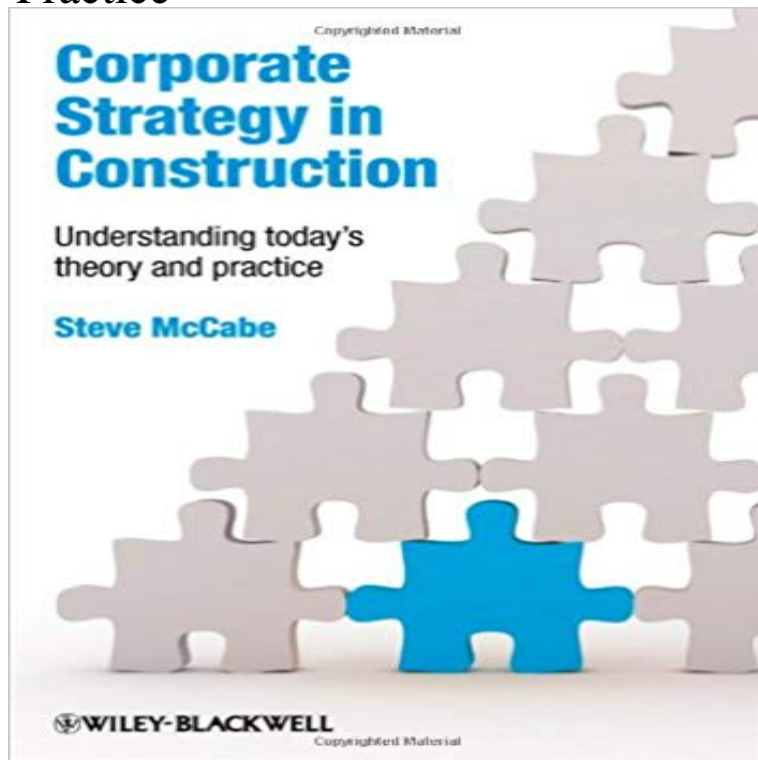


Corporate Strategy in Construction: Understanding Today's Theory and Practice
